FEEDING DIRECTIONS

Feed continuously at the rate of 6.7 to 20.2 pounds per head per day. This will provide 100mg. to 300mg. of Lasalocid per head per day. Free choice mineral, clean fresh water and roughage should be made available at all times.

WARNING: The safety of this product has not been established in pre-ruminating cattle. Do not use in calves to be processed for veal.

CAUTION: The safety of Lasalocid in unapproved species has not been established. Do not allow horses or other equines access to feeds containing Lasalocid as ingestion may be fatal. Feeding this supplement undiluted or mixing errors resulting in excessive concentrations of Lasalocid could be fatal to cattle.
